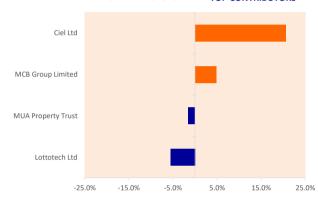

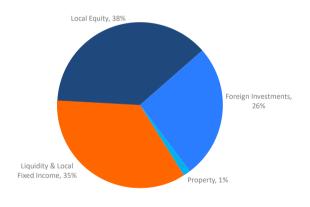


TOP DETRACTORS² TOP CONTRIBUTORS²
