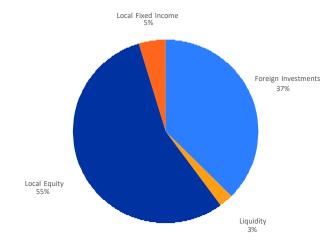

ASSET ALLOCATION



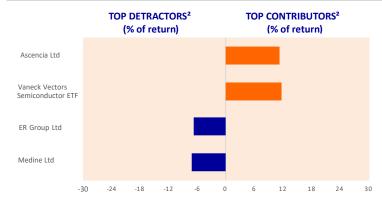
